

10 Steps for the Safety & Success of OUR Students

- 1. Watch a brief video...

- “click” on this hyperlink
- Give the movie a minute or so to load
- Allow the video to ‘tug’ at your heart



- 2. Join a “Community of Learners”...

- i.e., a group of individuals who are willing to learn and share so that we can better protect children with disabilities from maltreatment

- **3. Have a conversation...**

- “Did you know that children with disabilities experience child maltreatment at a rate that is three times greater than that experienced by their nondisabled peers?”
- “Did you know that children between the ages of birth through 3 years experience the highest incidence of maltreatment?”

- **4. Share the URL for our WWE with a colleague and encourage them to look at one or more of the presentations...**

- **5. Share a resource...**

- i.e., a Web page, document, agency, program, individual, etc. that you value and rely upon to address the topic of maltreatment as experienced by individuals with disabilities.
- Send the resource, along with a brief explanation of the resource and why you are suggesting it to Harold Johnson at hjohnson@msu.edu

- **6. Ask a question of a program administrator...**

- “What are we doing to prevent, or at least effectively observe, report, and respond to suspected/confirmed cases of child maltreatment?”
- Share their response with Harold Johnson at hjohnson@msu.edu

- **7. Request training and support from a program administrator...**

- “I know I am a mandatory reporter of child maltreatment, but I need more information regarding how to prevent, recognize, report and respond to suspected/confirmed cases of maltreatment. I also know that I will need ongoing support re. this critical, yet difficult topic. When, where, and how can I get this training and support?”

- **8. Identify and nominate a “Bright Spot,” ...**

- i.e., a trusted and valued member of your community that is recognized for their knowledge and skills concerning both child maltreatment and children with disabilities.

- **9. Call , 1-800-4-A-CHILD...**

- When you suspect a child may be experiencing maltreatment.
- You will have a confidential conversation with a counselor who will help you to decide if what you are observing is a likely case of abuse or neglect + identify who you can call to report your suspicion.

- 10. When a child tells you that they are being neglected, or abused, believe them, report the maltreatment to the [FL Abuse Hotline](#), then provide the child with a safe and accepting setting.
